Mr. Slim LIMITED WARRANTY

Mitsubishi Electric Mr. Slim® Split-ductless Air-conditioner and Heat Pump Systems

The HVAC Division of MITSUBISHI ELECTRIC & ELECTRONICS USA, INC. ("MEUS") warrants as follows to the original owner of this Mr. Slim product that, if purchased from and installed by a contractor licensed for HVAC installation under applicable local and state laws within the continental United States, Alaska and Hawaii, should it prove defective by reason of against defects arising from improper workmanship and/or material:

- **a.** One Year on Parts. The parts (except for the compressor) are warranted for a period of one (1) year after the date of the original installation by a licensed contractor at the owner's premises. We will provide a replacement for any defective part without charge for the part. Parts used for replacement may be replaced with those of like kind and quality and may be new or remanufactured. Parts used for replacement are warranted for the remainder of the original warranty period. Defective parts must be made available to MEUS in exchange for the replacement part and become the property of MEUS.
- **b. Six Years on Compressor.** The compressor is warranted for a period of six (6) years after the date of the original installation by a licensed contractor at the owner's premises. We will provide a replacement compressor which shall be warranted for the remainder of the original warranty period.
- c. No Labor. THIS LIMITED WARRANTY DOES NOT INCLUDE LABOR or other costs incurred for service, repair, removal, installation, shipping or handling of defective or replacement Mr. Slim product or parts. Some or all of such costs may be covered under a separate and independent warranty provided by your licensed contractor. For certain items that are designed to be replaced by the owner, you are solely responsible for any replacement labor. Air filter cleaning is normal consumer-required maintenance and labor for this procedure is not covered under warranty. Please refer to the Operating Instruction Manual for air filter cleaning procedures.
- **d. Proper Installation.** This Limited Warranty applies only to Mr. Slim products that are installed by contractors who are licensed for HVAC installation under applicable local and state law and who install the Mr. Slim product in accordance with all applicable building codes and permits, utilizing MEUS's installation and operation instructions and following good trade practices.
- **e. Timely Notice.** To obtain warranty service and parts replacement, you must notify the contractor who installed the Mr. Slim product or your nearest MEUS Mr. Slim product contractor, dealer or distributor, whose name and address may be obtained on our website at www.mehvac.com of any defect within the applicable warranty time period.

BEFORE REQUESTING SERVICE, please review the Operating Instruction Manual to insure proper installation and correct customer control adjustment. If the problem persists please arrange for warranty service.

- 1. TO OBTAIN WARRANTY PARTS SERVICE:
- a. Contact the contractor who installed your Mr. Slim product or your nearest MEUS Mr. Slim product contractor, dealer or distributor;, b. Proof of the installation date by a licensed contractor is required when requesting warranty service. Present your sales receipt, building permit or other document which establishes proof and date of installation. Otherwise, this Limited Warranty shall be deemed to begin one hundred twenty (120) days after the date of manufacture stamped on the Mr. Slim product. THE RETURN OF THE OWNER REGISTRATION CARD IS NOT A CONDITION OF COVERAGE UNDER THIS LIMITED WARRANTY. However, please return the Owner Registration Card so that we can contact you should a question of safety arise which could affect you.
- c. This Limited Warranty applies only while the Mr. Slim product remains at the site of the original installation (except for mobile homes) and only to locations within the continental United States, Alaska and Hawaii.
- 2. THIS LIMITED WARRANTY DOES NOT COVER property damages, malfunction or personal injury caused by or resulting from: [a] accident, abuse, negligence or misuse; [b] operating the Mr. Slim product in a corrosive or wet environment containing chlorine, fluorine or any other chemical hazardous to the Mr. Slim product; [c] installation, alteration, repair or service by anyone other than a licensed contractor or other than pursuant to the manufacturer's instructions; [d] improper matching of components of the Mr. Slim product; [e] improper or deferred maintenance contrary to the manufacturer's instructions; [f] physical abuse to or misuse of the product (including any failure to carry out any maintenance as described in the Operating Instruction Manual including air filter cleaning or any product damaged by excessive physical or electrical stress); any products that have had a serial number or any part thereof altered, defaced or removed; product use in any manner contrary to the Operating Instruction Manual; freight damage; or any damage caused by force majeure or other factors beyond the reasonable control of MEUS, such as power surge damage caused by lightning and fluctuations in or interruptions of electrical power and flood.
- 3. This Limited Warranty also excludes service calls where no defect in the product covered under this warranty is found, all costs, expenses or any other damages arising from product installation or set-ups, any adjustments of user controls or service of products purchased or serviced outside the continental United States, Alaska and Hawaii. Please consult the operating instructions contained in the Operating Instruction Manual furnished with the product for information regarding user controls.
- 4. YOUR ONLY REMEDIES ARE PROVIDED IN THIS LIMITED WARRANTY. ANY EXPRESS WARRANTY NOT PROVIDED HEREIN, AND ANY REMEDY WHICH, BUT FOR THIS PROVISION, MIGHT ARISE BY IMPLICATION OR OPERATION OF LAW, IS HEREBY EXCLUDED AND DISCLAIMED. THE IMPLIED WARRANTIES OF MERCHANTABILITY AND OF FITNESS FOR ANY PARTICULAR PURPOSE ARE EXPRESSLY LIMITED TO A TERM OF ONE YEAR FROM THE ORIGINAL INSTALLATION DATE.
- 5. UNDER NO CIRCUMSTANCES SHALL MEUS BE LIABLE TO PURCHASER OR ANY OTHER PERSON FOR ANY INCIDENTAL, SPECIAL OR CONSEQUENTIAL DAMAGES, WHETHER ARISING OUT OF BREACH OF WARRANTY, BREACH OF CONTRACT, OR OTHERWISE.
- 6. Some states do not allow limitations on how long an implied warranty lasts, or the exclusion or limitation of incidental, special, or consequential damages, so the above limitations or exclusions may not apply to you.
- 7. This Limited Warranty gives you specific legal rights, and you may also have other rights which vary from state to state.
